TERMS OF USE AGREEMENT FOR THE CAEP SECURE PORTAL

You have requested an account for an ICAO CAEP secure portal site. Your access to the CAEP_WG3 secure portal is conditional to your acceptance of the following use agreement and your compliance with its terms:

USE AGREEMENT FOR THE CAEP SECURE PORTAL SITE

- 1. This use agreement sets out the terms of access to the information made available on the CAEP_WG3 secure portal, which is provided solely for the purposes of supporting the work of CAEP WG3.
- 2. Access to the CAEP_WG3 secure website is given only to (i) CAEP members, (ii) CAEP observers, and (iii) their nominated experts, for the limited purpose specified in this use agreement.
- 3. By accessing the CAEP_WG3 secure website, the user confirms that he / she holds a valid and current status as a (i) CAEP member, (ii) CAEP observer, or (iii) nominated expert, and agrees to abide by the terms of use set out in this use agreement.
- 4. The information provided in the CAEP secure site shall be used for the sole purpose of supporting the work of CAEP WG3. Copying, unauthorized disclosure or dissemination of the information or any content of the CAEP_WG3 secure site to any person who is not an authorized user, or use of the information or any content of the CAEP_WG3 secure site for any unauthorized purpose, is strictly in violation of this use agreement. If this use agreement is violated, ICAO will request that the respective user and unauthorized recipient of information be excluded from the CAEP process by their Member State or observer organization. ICAO also reserves the right to take such other action against users found to have violated the terms of this use agreement, including but not limited to revoking access to the CAEP_WG3 secure portal.
- 5. This CAEP_WG3 website and database contains documents and other material, protected under applicable copyright laws. It is prohibited, without the express written permission of ICAO, to perform any of the acts mentioned below:
- 1. Other than for the permitted purpose, to reproduce, directly or indirectly, the material in any manner or form, including, but not limited to, printing on paper or on any other medium, electronic storage in any form, including temporary or permanent storage in computer memories or storage media of any kind, and recording of the material on any medium from which it can be retrieved or reproduction of such recording;
- 2. To display or exhibit the material in public or to communicate the material in any way to other persons, including broadcasting, cable communication and digital or analogue transmission; and

- 9. The obligations of the user under this agreement shall continue after they cease to be a CAEP participant or to have access to the site.
